**NOTIFICATION**

With reference to Advertisement No. NTS – 1 / 2017 dated 16.03.2017 for the post of “Placement Officer, G.U.”, it is notified for information to all applicants that a Written Test (Screening Test) shall be held for the purpose on Oct 10, 2017 (Tuesday) .

The test shall be of 100 marks and shall consist of two groups of questions as follows:

(a) Group A (80 marks): This group shall consist of 80 multiple choice questions (MCQ’s) with the following broad components:

- (i) General English – Around 30 questions.
- (ii) Reasoning & Mental Ability – Around 20 questions.
- (iii) Data Interpretation – Around 10 questions.
- (iv) General Awareness – Around 20 questions.

Each correct answer will be awarded 1 (one) mark, while each wrong answer will be penalized by 0.25 (negative marking).

(b) Groups B (20 mark) : This group will require descriptive answers. Questions in this group will broadly test the understanding and ability of the candidate to fulfill the role of ‘Placement Officer’ of the university.

Other details of the Written Test (Screening test) along with venue, timing etc. shall be communicated in the admit card to be sent separately to applicants who have been shortlisted for the written test (list enclosed in annexure). All applicants must bring a valid ID proof with photograph and a black ball point pen for the examination.
